All my research has been preoccupied with understanding the forms of power in capitalism, with a particular interest around the nexus between material and symbolic power. My core empirical work is focused on the political economy of the City of London as a major centre of global commerce. Prior research concentrated on two other areas of capitalism: (1) trade (WTO; NGOs and trade policy); and (2) ideology (neoliberalism, the politics of managerialism).
